At the start of September 2008, pursuant to the approval of the University Board, the Rector of the Saint Joseph University of Beirut, Prof. René Chamussy, SJ, inaugurated a center for university studies in Dubai, in the presence of His Highness Sheikh Mohammed bin Rashid al Maktoum, Prime Minister and Vice President of the United Arab Emirates, Ruler of the Emirate of Dubai.

Since its inauguration in 2008, the School of Law in Dubai (FDSPD) has been offering a prestigious Bachelor of Law program to students living in the United Arab Emirates with the aim of preparing them to become leaders in the legal market. The School has, in fact, designed a special program tailored to the Emirati and the GCC legal framework, while maintaining the same academic values of the program offered at the Faculty of Law and Political Science in Beirut.

After more than ten years of establishment in Dubai, the School of Law in Dubai has designed a master program entitled "Master of Laws in Business Law". This program offers students the opportunity to delve into the most demanded topics in the field of business law.

SPECIFIC PROVISIONS OF THE INTERNAL REGULATIONS OF STUDY

I- Credits

Each program offered by the University requires the completion of a number of credits. For example, in order to obtain a Bachelor's degree, students shall pass 240 European credits (equivalent to 120 US credits). The total number of credits includes the credits of language courses offered by the university (Arabic, French and English), and the credits of the core and elective courses. The student is expected to allocate an average of 23.5 hours to 26.5 hours of study for each credit.

Students may register in a maximum of 60 new ECTS credits per year.

II-<u>Semesters</u>

The academic year consists of two semesters of 14 to 16 weeks each.

III- Attendance

Attendance is mandatory for theoretical lessons, supervised work, and practical work. The absence rate in any course shall not exceed 20% of the teaching hours.

If there is a conflict between attending a course in which the student has failed, and a new course that they have not previously taken, attendance preference will be given to the new course if it includes practical works. In order to grade the student in the failed course, the student must, under the supervision of the course instructor, be responsible for preparing all assignments, conducting research and submitting examinations. In the absence of such conflict, the student is obliged to attend the lectures of both courses and participate in the relevant supervised work.

IV- Grading

Students are graded according to the following:

- a. The exam grade is out of twenty points.
- b. The coefficient for each course is determined based on the number of credits allocated to that course.
- c. For courses subject to supervised work, the final grade consists of 50% for the "supervised exercises" grade and 50% for the final exam grade.
- d. All courses, with the exception of courses subject to supervised work, are subject to the practical work (TPC) system. The final grade for these courses consists of 25% of the grade for the practical work and 75% for the final exam.
- e. As for language courses, the final grade consists of 50% for the practical work grade and 50% for the final exam grade.

V- Exam sessions

- a. An exam session is organized at the end of each semester (January for the first semester; June for the second semester).
- b. A retake session is organized at the end of every semester: one in February for the first semester and another in September-October for the second semester.
- c. Regardless of the reason, a student shall not be absent during any exam session. If a student misses the two final exam sessions of a specific course, they will have failed that specific course. This absence shall not be compensated for by organizing an examination at a later date except in one of the following cases (provided that it is proven by an official document, accepted by the Vice Dean or the Head of program):
 - The death of a parent, brother, sister, husband, wife, or sons or daughters
 - The student's illness with a serious and/or contagious disease, confirmed by medical reports
 - General Force Majeure

VI- Course validation and credit earning

A student will fail a course if their final grade, including the grade of the final exam and practical works is below 10/20. In order to earn the credits of the failed course, they must register again and succeed.

The student's GPA is calculated at the end of each academic year based on the courses in which they are registered and after the re-take exams, if applicable. The minimum GPA shall permanently be equal to (2) to allow the student to advance in their academic path. A student who does not have a GPA of 2 at the end of their 2nd year is placed on probation, and accordingly must meet the required average during the academic year that follows the probation. If their GPA remains less than 2 at the end of the 3rd year, they will have to re-register for the courses they had previously registered for to raise their GPA and will not be allowed to register in new courses.

VII- Student progression

Enrollment in some courses is conditional upon the completion of pre-requisite courses.

VIII - Fraud and attempted fraud

In the event of fraud during the exams, the student's exam paper is automatically annulled by the Vice Dean. They will be awarded a zero on this exam, and no further exam will be organized to compensate for the grade obtained. The student will also face disciplinary measures.
