■ LL.M. in Business Law

The LL.M. in Business Law aims to provide high-level training for legal professionals, perfectly bilingual in French and English, and familiar with the rules and practice of business law in domestic and international relations.

The LL.M. in Business Law of the Faculty of Law and Political Science at Saint-Joseph University of Beirut is a one-year postgraduate degree. It aims at providing a solid academic legal training to students and legal professionals who specialize in the field of business law and wish to enhance their skills and careers in law firms, banks or major companies in Lebanon and abroad.

The program is designed to familiarize the candidates with the rules and practices of Business Law in both domestic and international relations, and allow them to adapt to various legal systems.

It also aims at providing the required skills for negotiating and drafting legal documents.

■ Admission Requirements

Candidates must hold a Lebanese Bachelor of Law (M1) or an equivalent diploma.

They are selected based on their academic record and/or professional experience, and, if necessary, after an interview with the selection committee.

Proficiency in English and French is mandatory.

Applicants must provide an academic transcript, a cover letter and a curriculum vitae.

The LL.M. in Business Law extends over an academic year divided into two semesters.

Obtaining the degree requires the validation of 60 credits.

Le LL.M. en Droit des affaires a vocation à assurer une formation de juristes de haut niveau, parfaitement bilingues, en français et en anglais, et rompus aux règles et à la pratique du droit des affaires dans les relations internes et internationales.

Le LL.M. en Droit des affaires de la Faculté de droit de l'Université Saint-Joseph de Beyrouth est un diplôme de 3e cycle d'une durée d'un an. Il a vocation à assurer une formation à des étudiants et des professionnels spécialisés en droit des affaires et appelés à exercer une activité professionnelle au sein de cabinets d'avocats, de banques ou de grandes entreprises au Liban et à l'étranger.

Le programme des enseignements a pour but de former des praticiens rompus aux règles et à la pratique du droit des affaires dans les relations internes et internationales et susceptibles de s'adapter à la diversité des systèmes juridiques.

Le programme vise également à donner aux étudiants les compétences nécessaires pour maîtriser les techniques de négociation et de rédaction d'actes juridiques.

Ils sont sélectionnés sur la base de leur dossier universitaire et/ou de leur expérience professionnelle ainsi que, le cas échéant, après un entretien avec le comité de sélection.

La maîtrise de l'anglais et du français est obligatoire.

Les dossiers de candidature doivent comporter le dossier universitaire, une lettre de motivation et un curriculum vitae.

Le LL.M. s'étend sur une année universitaire divisée en deux semestres.
Son obtention nécessite la validation de 60 crédits.
