



## ERASMUS+ INTERNATIONAL CREDIT MOBILITY

### Student Mobility for Studies (SMS) from Universities based in Erasmus+ Partner Countries

International Credit Mobility is the Erasmus+ exchange scheme for the mobility of students and staff of European Universities with partners worldwide. An institution in a Programme Country<sup>1</sup> can send its students and/or staff to a partner institution in a Partner Country and vice versa.

Students can study in Cyprus and may benefit from an Erasmus+ grant to help with traveling and living costs. Within the framework of Erasmus+ International Credit Mobility, Open University of Cyprus (OUC) has secured funding to welcome incoming students for one academic semester at OUC undergraduate or postgraduate programmes (at Master level), and cover their Erasmus+ grant.

Incoming students will have the chance to experience OUC's blended learning methodology, by attending courses both with physical presence (although limited) and online via the University's eLearning platform, interact with their tutors, obtain new knowledge and skills from a European university, meet new people, language and culture.

### POTENTIAL BENEFICIARIES

- **Bachelor degree students** (not in the 1<sup>st</sup> year of their studies) in Subject Areas / Scientific Fields covered by Erasmus+ Inter-Institutional Agreements.
- **Master's degree students** in Subject Areas / Scientific Fields covered by Erasmus+ Inter- Institutional Agreements.
- **PhD students**, who have completed at least one year of study.

All incoming students are expected to have **a minimum English language proficiency level of B2.**

<sup>1</sup> The 32 Programme Countries are: the 27 EU Member States, Iceland, Liechtenstein, Norway, the Republic of Northern Macedonia, Serbia and Turkey. Partner Countries are all the other countries in the world.

For students interested in Programmes of Study that are offered in Greek their applications / Learning Agreements will be evaluated and approved firstly by the relevant Academic Coordinator to ensure that some Modules / Courses can be offered in English. Hence, nominated students should primarily concern the English-taught Programmes.

### IMPORTANT

- Exchanges of students and staff under the Erasmus+ ICM scheme can only take place between Universities that have signed an Erasmus+ Inter-Institutional Agreement, specifying the conditions of mobility.
- To apply for an Erasmus+ SMS grant and visit OUC for an academic semester, students of Partner Universities need to make sure that the Inter-Institutional Agreement signed between OUC and their home University covers their study areas.
- There is specific budget and number of available incoming mobility positions that cannot be exceeded.
- Incoming students do not pay tuition fees at the Open University of Cyprus. Any fees that concern the modules that will be recognized at their home University are dealt with their home University.

### MOBILITY DURATION

➤ **The minimum duration of mobility is 2 months with two exceptions:**

a) People with fewer opportunities:

**The Open University of Cyprus and the Erasmus+ Programme support the participation of students with fewer opportunities.**

Specifically, students and graduates with fewer opportunities are considered individuals:

- with physical, mental and mental disabilities,
- with physical and mental health issues,
- with a low socio-economic background,
- with an immigrant/refugee background,
- students/graduates, political refugees,
- people who are children of single-parent or large-child families from a low socio-economic background,
- people who are parents themselves and belong to the category of people from low socio-economic backgrounds,
- people from rural, deprived and remote areas,
- people from dysfunctional families, as well as students/graduates with Learning Difficulties (e.g. dyslexia, dysgraphia, dyspraxia, etc.),



- as well as individuals who are parents or have careers that are not included in the above categories and cannot be absent abroad for an extended period.

#### b) PhD candidates

Students who belong to the aforementioned categories a) or b) and who are unable to participate in periods of long-term physical mobility for studies, can combine a shorter period of physical mobility with elements of virtual mobility (blended mobility).

- a) People with fewer opportunities can move to the Open University of Cyprus for a period of 5 to 30 days: The minimum duration with physical mobility is 5 days. In short-term mobilities in these cases, an online component is mandatory.
  - b) Study mobility for PhD candidates: To better meet the different learning and training needs of PhD candidates and to ensure equal opportunities, PhD students reserve the right to apply for short-term mobility of between 5 and 30 days, or for long-term mobility from 2 to 12 months in person. In the case of short-term mobility, the online component is not mandatory.
- All mobilities for the 2024-2025 Spring Semester must be completed by July 31, 2025.

## APPLICATIONS PROCEDURE

### Step 1: Apply for Erasmus+ study period at OUC

Applications are submitted as follows:

- (a) Find a suitable degree programme offered by the Open University of Cyprus:
  1. Should a student of a Partner University is interested to visit OUC, s/he must contact the International Relations Office of the home University in order to verify that the Inter-Institutional Agreement signed by the two Universities includes his/her subject areas.
  2. The student should then check all OUC programmes of study, and the modules/courses offered. Information can be found at the following link:

In collaboration with the Academic Coordinator/Head of the programme s/he attends at home University, they must fill in the “Learning Agreement” form (provided by OUC Mobility Office or Home University’s IRO) with a) the modules that the student will register to attend at the Open University of Cyprus, and b) the modules that



will be recognized at home University as part of the Erasmus+ mobility for studies. The Learning Agreement must be submitted electronically (via email) to the International Relations Office of the home University within specified deadlines (respecting OUC's own deadline).

### Step 2: Application Evaluation Process

1. All applications submitted to the International Relations Office of the sending Institution must be reviewed in accordance with the selection criteria mentioned in Annex I in order to establish a nominations' list with selected, runner up, and rejected candidates.
  
2. All information regarding the selected and runner up candidates, should include:
  - Their individual Learning Agreement with the courses meant to be attended during their mobility period in the OUC and the corresponding courses (stated with the ECTS equivalents) at the sending University. The Learning Agreement is the most important document for Erasmus+ SMS beneficiaries, and its purpose is to provide a transparent and efficient preparation of the exchange, to make sure that students receive recognition for the activities successfully completed abroad. The student, the sending and the receiving university, before the start of the exchange, must sign it.
  - Their Transcript of Records showing the courses already completed at the sending University and thus cannot be attended again during the mobility period at the Open University of Cyprus, and
  - An English language knowledge certificate e.g. IELTS, IGCSE, TOEFL etc. of minimum level B2 (if the teaching language is not their mother tongue).

and must be submitted to the OUC Mobility Office: [erasmus@ouc.ac.cy](mailto:erasmus@ouc.ac.cy) by the said deadline.

3. Based on this nominations' list, competent authorities of the Open University of Cyprus will review all applications and establish the final list of beneficiaries in accordance with the selection criteria mentioned in Annex I, and the number of available mobility positions per country. The OUC Mobility Office will inform accordingly both the students securing the Erasmus+ grant for studies at OUC, and the International Relations Office of their home University.

### Step 3: Approval of Erasmus+ Grant

1. Following the announcement of the results, all beneficiaries will be invited to sign an Erasmus+ Grant



Agreement with the Open University of Cyprus. Erasmus+ grant<sup>2</sup> for incoming students is financed by OUC.

### ACCOMMODATION, INSURANCE AND VISA REQUIREMENTS

- The Open University of Cyprus is a public University, which is specialised in open and distance education. It does not have dormitories, thus private accommodation needs to be secured by the student. The OUC Mobility Office will support this process as much as possible.
- Incoming students for studies must have adequate Health Insurance covering the duration of their mobility in Cyprus and the Open University of Cyprus.
- Since the “Erasmus+ International Students Mobility for Studies” action concerns student exchanges between Programme and Partner Countries, there is the additional element to consider, that concerns visa requirements. All potential beneficiaries should reflect on this and undertake all necessary actions timely to ensure that in case they need an entry permit to travel to Cyprus and subsequently a temporary residence permit required for students from countries outside the EU/EEA Zone, they have adequate time to secure it. - Visa, if needed, should be issued at least three (3) weeks prior to the scheduled start date of the mobility period, otherwise Erasmus+ grant cannot be secured and the Open University of Cyprus has the option to decline beneficiaries and provide funding to runner-ups.

### AT THE END OF THE MOBILITY PERIOD

For the successfully completed courses ECTS are awarded.

After the completion of the mobility period, all beneficiaries should submit to OUC Mobility Office the following documents and certificates, as stipulated in the Erasmus+ Grant Agreement in order to receive their Erasmus+ grant:

- EU final Report: must be filled in and submitted online via the EU’s Beneficiary Module. An automatically generated email will be send to the beneficiary’s email account after the end of the mobility period at OUC.
- Study Period Certificate: this certificate will be issued and signed by the Academic Affairs and Student Welfare Services and will indicate the modules/courses attended at OUC by the incoming student.
- Transcript of Records: again, this will be issued by OUC.
- Traveling Documents: Erasmus+ beneficiary should submit the following documents to confirm the country of departure and the period of the mobility:

- Copy of air tickets and payment receipts
- Boarding passes to/from Cyprus/home country
- Testimonial and photographs for dissemination purposes.

## FUNDING

### ➤ Travel Grant

Travel grant is calculated based on travel distance between the participant's city of origin and the city of destination (Nicosia, as far as Open University of Cyprus is concerned). Distance is calculated using the following special distance calculation tool of the EU:

Distance	Amount per Participant (Euro, €)
Between 10 and 99 Km	23
Between 100 and 499 Km	180
Between 500 and 1999 Km	275
Between 2000 and 2999 Km	360
Between 3000 and 3999 Km	530
Between 4000 and 7999 Km	820
Equal or more than 8000 Km	1.500

➤ Subsistence Grant

The monthly subsistence grant for Cyprus, which is financed by OUC, based on the Erasmus+ programme provisions, amounts to 850 euro.

- Students with fewer opportunities receive an additional support on top of the EU grant above, to cover individual costs under the Erasmus+ Programme, amounting to 250 EUR per month.

Students on short-term physical mobility (blended mobility and doctoral short-term mobility) receive daily subsistence, irrespective of the host country, as follows:

Duration of the physical activity	Daily Erasmus+ grant (€)
Up to the 14th day of activity	70€ per day
15th to the 30th day of activity	50€ per day

- Students with fewer opportunities receive a top-up amount to the individual support of their EU Erasmus+ grant of an amount of 100 EUR for a physical mobility activity period of 5-14 days and 150 EUR for the one of 15-30 days.

## SELECTION CRITERIA

### INCOMING STUDENT MOBILITY FOR STUDIES AT OUC

Selection criteria for the evaluation of applications submitted by students of Universities based in Partner Countries and collaborating with Open University of Cyprus under Erasmus+ International Credit Mobility include the following:

- Students with fewer opportunities have priority.
- Grade point average (GPA), based on home University Transcript of Records/Grades report.
- English language level of proficiency: the minimum academic requirement for the Open University of Cyprus is B2 (official language certificates such as IELTS, IGCSE, and TOEFL are accepted plus certificates from the home university).
